

PARTICIPATION SPORTSMANSHIP COMMITMENT, WAIVER OF LIABILITY, MEDICAL RELEASE, HOLD HARMLESS WAIVER AND PRIVACY POLICY

Registrants for all Memphis Futsal Arena (MFA), programs must accept the following Participation Sportsmanship Commitment, Waiver of Liability, Medical Release, and Privacy Policy in order to submit their registration order (see further below for the additional waiver pertaining to Adult Divisions):

In consideration for my voluntary participation in organized soccer activities through Memphis Futsal Arena (MFA), I hereby willfully acknowledge to my understanding and agreement that:

I will not compromise myself in such a way as to do harm to the league or facilities, knowing that players may be dismissed from participation, with possible loss of payment or dues, for violent conduct or unsportsmanlike behavior on or off the field of play. I will exhibit good sportsmanship in all my activities and remember that this is a recreational program, open to the public of all skill levels, without an emphasis on winning. I will conduct myself appropriately in interactions with youth, parents, coaches, league administrators and officials. I will also report any observed violations of good or bad sportsmanship that I witness to the league. I agree to pay for any and all damages to any property or indemnities caused by me willfully, negligently, or otherwise.

Memphis Futsal Arena (MFA), will host physical, contact, sport's that involves the risk of injury. I assume all risks and hazards associated with my participation in the sport programs. I am in proper physical condition to take part in any sport program practices, games, or events and have no illness, disease or existing injuries or physical defect that would compromise my wellbeing by my participation. I will inform the league if this status changes. I further acknowledge that this risk may involve loss or damage to me or my property, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care. I have a current medical consent form in force. I will wear properly fitted attire and appropriate shoes, and other protective equipment, as provided by soccer rules, and follow other safety guidelines issued by the league, to all events.

I authorize my photograph, picture or likeness, and voice to appear in any documentary, promotion (including advertising), television, video, or radio coverage of the league or tournament, without compensation. Participants will never be tagged/identified on social media or the other above-mentioned sources without written consent.

I hereby release, waive liability, discharge, hold harmless, indemnify, and covenant not to sue, Memphis Futsal Arena (MFA), their associated directors, administrators, officers, managers, employees, coaches, trainers, volunteers, sponsors and advertisers, and other agents, estates or executors, from any and all liability incurred in the conduct of, and my participation in, their sport's programs. This includes owners, lessors, and lessees of premises, municipalities, government agencies, successors, heirs, and assigns.

For applicable Recreational programs (Memphis Futsal Arena Hold Harmless Waiver): WE HEREBY AGREE THAT THE Memphis Futsal Arena (MFA), ITS MEMBERS, COACHES OR OFFICERS SHALL NOT BE LIABLE FOR ANY INJURY OR LOSS WHICH MY CHILD MAY SUSTAIN WHILE PARTICIPATING IN ACTIVITIES OF ANY KIND WHETHER SPONSORED BY OR UNDER THE SUPERVISION OF SAY AND WE AGREE TO INDEMNIFY AND TO HOLD HARMLESS SAY, ITS MEMBERS, COACHES, OFFICERS OR DESIGNATES OF ANY KIND FROM ANY CLAIM WHATSOEVER.

I have completely read this document and fully understand its contents. I acknowledge that I have given up certain rights by accepting this document and that I do so voluntarily.

For those individuals under the age of eighteen (18) years (minor): As the parent and natural guardian or legal guardian of the participant, I hereby agree to the foregoing Waiver of Liability and Release for, and on behalf of, the participant (player/minor) named above. I hereby bind myself, the minor, and all other assigns to the terms of the Waiver of Liability and Release. I represent and certify that I have the legal capacity and the authority to act for, and on behalf of, the minor in the execution of this Waiver of Liability and Release.

For those participating in Adult Divisions, the following, in addition to the language included above, applies upon acceptance of the waiver in the registration process:

ASSUMPTION AND ACKNOWLEDGMENT OF RISKS AND RELEASE OF LIABILITY AGREEMENT

In consideration of being allowed to participate in any way for Memphis Futsal Arena (MFA), Its Affiliates, Leagues, and Member Teams, its related events and activities, the undersigned, acknowledges, appreciates, and agrees that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will bring such violation to the attention of the nearest official immediately; and
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Memphis Futsal Arena (MFA). Its Affiliates, Leagues and Member Teams, their officers, officials, agents and/or employees, other participants sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

FOR PARENTS/GUARDIANS OF PARTICIPANTS OF MINORITY AGE (UNDER AGE 18 AT TIME OF REGISTRATION) This is to certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree to his/her release as provided above of all the Releasees, and, for myself, my heirs, assigns, and next of kin, I release and agree to indemnify and hold harmless the Releasees from any and all liabilities incident to my minor child's involvement or participation in these programs as

provided above, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law.

Youth Waiver & Sportsmanship Pledge

1. Voluntarily and of my own free will, my son/daughter elects to participate as a member of Memphis Futsal Arena (MFA), Association and or any team.

Further, I, the undersigned parent, agree that in consideration for the right to play as a member of the any team and in consideration for permission to play on the fields arranged for by the team or Memphis Futsal Arena (MFA), I voluntarily elect to accept and assume all risks of injury incurred or suffered by my child (a) while practicing or playing as a member of the team so designated, (b) while serving in a non - playing capacity as team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or Memphis Futsal Arena (MFA), for practice or play.

I further understand that games, parties, functions, meetings and more may be photographed, or video recorded. This media may be used for advertising, promotions, website and more. I do allow The Memphis Futsal Arena (MFA), to use any media gathered for the manners mentioned without my consent. No personal information will ever be used.

It is the belief of the Memphis Futsal Arena (MFA), that all three of these important elements begin with individual members and extend to entire teams, parents & families. Furthermore, it is the responsibility of every player, fan and supporter of the Memphis Futsal Arena (MFA) to ensure that they do their individual part to promote the core beliefs of the Memphis Futsal Arena (MFA). While the appropriate level of competitive play is expected in the appropriate leagues, it shall be understood that at no time should the Spirit of the game or any player, fan or supporter be made to suffer at its expense. Everyone is charged with the responsibility of developing a bond of mutual respect among all players, adherence to agreed-upon rules of play/conduct, promoting the Memphis Futsal Arena (MFA), and for fostering a love for recreational sports. Actions such as taunting in an extreme manner, name calling, excessive profanity, dangerous aggression, intentional fouling, or other 'win at all costs' behavior are hereby strictly forbidden and are considered contrary to both the Spirit of the game and to the Mission of the Memphis Futsal Arena (MFA), and must be avoided by all players.

Memphis Futsal Arena (MFA), has instituted a Zero Tolerance Policy for poor sportsmanship, extremely aggressive behavior, trash talking that does not fit within the Memphis Futsal Arena (MFA) code of conduct and for any behavior that is "contrary to the Spirit of the Game." Furthermore, excessive profanity, especially stemming from disagreements or during taunting will not be allowed and will be considered an example of poor sportsmanship and will be subject to penalties.

I _____ the parent or guardian of a Memphis Futsal Arena (MFA), sports team player, agree that the most important outcome of any game is for my child to have fun. My child needs my approval and support, regardless of what happens in the game. I will refrain from the use of negative or derogatory language aimed at the Officials, the Coaches, (MFA) staff, my child, or other players. I will encourage my child and all others in the game and will let the coach be the coach. I will do my best to model the sportsmanship-like behavior I wish my child to adopt, and to support the coach in making this the best possible experience for my child."
